I. Joint Controllers manage your personal data together to organise the recruitment process for Candidates who have submitted their application documents as part of spontaneous recruitment or have agreed to participate in future recruitment procedures.

II. The Joint Controllers undertake to limit access to your personal data only to persons whose access is necessary for the aforementioned purposes. In addition, the Joint Controllers shall ensure that only persons who have been given a personal data processing authorisation in their name, that persons authorised to process personal data have undertaken to keep their personal data secret and have been previously trained in the rules and regulations on personal data protection are allowed to process personal data.

III. Joint Controllers shall ensure an appropriate level of personal data security. To ensure security, the Joint Controllers shall ensure:

- the ability to continuously ensure the confidentiality, integrity, availability and resilience of personal data processing systems and services;
- the ability to quickly restore the availability of and access to personal data in the event of a physical or technical incident;
- regularly testing, measuring and evaluating the effectiveness of technical and organizational measures to ensure processing security;
- where appropriate and possible, the Joint Controllers undertake to use, where the risk so requires, pseudonymisation and encryption of personal data.

In all matters concerning the protection of your personal data, you may contact both the Joint Executive Controller and the other Joint Controllers, but the Joint Executive Controller is responsible for answering you.
